**NOTICE OF RACE**

**Organization**

The Yacht Club de Cavalaire, affiliated to the Fédération Française de Voile, in conjunction with 29er class, organise the Eurocup, french meeting from 03 to 05 April 2010.

**1. REGLES**

The regatta will be governed by:

- 1.1 The rules as defined in The Racing Rules of Sailing 2009-2012,
- 1.2 The prescription of FFVoile,
- 1.3 The current class rules,
- 1.4 If there is a conflict between languages, the French text will take precedence

**2. ADVERTISING;**

In accordance with ISAF Regulation 20 (Advertising Code) as modified by the Advertising regulation of the FFVoile, boats may be required to display the advertising chosen and supplied by the organizing authority. The regatta is classified as category "C" code of advertising

**3. ELIGIBILITY AND REGISTRATION**

- 3.1 The event is open to all boat of the 29er class.
- 3.2 Eligible boats may enter by completing the entry form and sending it, together with the required fee to

3.3 Competitors (each crew member) living in France shall present during registration:

- the valid and signed FFVoile's licence with health certificate and a parents' permission for the minors,
- A valid authorization to display advertising on boat, if necessary

- The measurement form or certificate of the boat,
- Each crew member shall be a current member of the 29er Class

Foreign competitors without a French licence shall justify their membership to an ISAF Member national authority

#### 4. FEES

The entry fees are as follows, postmarked authentic.

- ◆ 130€ until March 20, 2010
- ◆ 150€ effective March 21, 2010

**Any entry not accompanied by a check will not be taken into account except for foreign crews, they will send their registration in advance and pay on site the sum of 130 €.**

#### 5. FORMAT EVENT.

In case of large numbers of entries, the opening series may be divided into qualifying series and final series. At least 4 qualifying races shall be completed by all groups in an event before to going to final round.

#### 6. SCHEDULE

#### 7. MESUREMENT

All boats must be in accordance with class rules. Mesurement Checks can be performed during the event on shore as on water.

#### 8. SAILING INSTRUCTIONS

The sailing instructions will be available at registration.

#### 9. COURSES

The courses will be windward/leeward

#### 10. PENALTY SYSTEM

Rule 44.1 is changed so that the two-turns penalty is replaced by the one turn penalty

#### 11. SCORING

**11.1.** At least 4 races shall be completed to constitute a regatta

**11.2** The low points system of RRS appendix A will apply

## **12. RADIO OR PHONE COMMUNICATION**

A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

## **13. PRIZE**

An awards ceremony will take place as soon as possible on the last day of the event.

Will be awarded:

The first three crews Men  
The first three women crew

## **14. SUPPORT BOATS**

Coaches or leaders with a boat must be returned before March 20, the registration form attached, duly completed, together with supporting documentation, to obtain a free seat to port. After that date, tickets will be at the expense of laggards.

## **15. DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. Decision to race or to continue racing is their own responsibility.

The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta

## **16. INSURANCE**

Each foreign competitor without FFVoile licence shall be insured with a valid third-party liability insurance with a minimum cover of 1 500 000 Euros.

The leaders and coaches will also be provided in at least the same conditions.
